- 1.) Call Meeting to Order by Katie Renville at 8:30AM

- a. Executive Cabinet Discussion Dr. Hirning (guest) was invited to discuss executive cabinet makeup. Faculty was concerned about not having a faculty member present during the cabinet meetings. ## 4.) New Business:

- a. CCF Info from Alexey Tenure and Presidential Search Policy Feedback Alex Kovalev (guest from CCF) discussed that the SBHE is looking to change some policies, one including the tenure policy and the other about the presidential search policy. For the tenure policy, the SBHE is trying to implement a policy that says in order to obtain tenure, a faculty member must hold a masters, professional, or doctorate degree. CCF has proposed to the SBHE that an alternative tenure pathway be put in place instead that would allow trades faculty to work toward tenure with other qualifications. Faculty senate supports what CCF has drafted. For the presidential search policy, the SBHE wants to add to the policy to include that a presidential search does not need to be conducted, and the SBHE can appoint a campus president. CCF is in opposition to this and is currently drafting a letter to the SBHE. Senate will review the CCF letter and give email feedback.
