International students, not including Canadians, are automatically enrolled by semester in the student insurance plan by their institution. The premium cost is billed to the international student's Campus Connection account. The first half of the student health insurance payments will be collected prior to the student arriving in the U.S. and the remaining balance collected in full no later than the end of the sixth week of a regular fall or spring term or equivalent date for a summer term or classes outside a regular term.
